LETTER FROM THE BOARD



Just over one year ago the then current EVNA board members regrouped and created the EVNA ad hoc Revitalization Committee. By the time our AGM was held in October 2020, many committee meetings had been held during which numerous major items were reviewed and decisions made about the functioning and operations of EVNA

During the seven months following the AGM 2020 the Committee's work continued and was wrapped up in January 2021. The committee was

formally dissolved in February 2021. Among its accomplishments were the following:

- a new branding for EVNA was put in place including a new EVNA logo.
- the adoption and implementation of Microsoft's Teams collaboration software to facilitate internal communications among board members and as a means for storing and sharing the organization's records and documents.
- new email addresses were established for board members based on the position held on the board, e.g. treasurer@yycevna.org.
- a new website and membership management system was installed and setup.
- an accounting / bookkeeping service was engaged.

Over the past eighteen months COVID-19 and the accompanying rules and regulations put in place have influenced our lives on a daily basis. Due to these regulations no traditional EVNA sponsored events were held during the seven months since our last AGM. However, in December 2020 we embraced the Christmas spirit through a few activities, *Derek Visits East Village*, a social media campaign, and *Light up the Village*, encouraging EV neighbours to participate remotely.

With the hope and expectation that COVID-19 rules would eventually be relaxed EVNA's Events Committee earlier this year planned a number of events for our EV neighbours. As well, a consulting firm was engaged to plan and execute EV Street Fair 2021.

Due to a number of circumstances, our first event, Spring Purge, was cancelled. As well, considering the uncertainty of a full re-opening in time for our July 1st EV Street Fair the decision was made to cancel our street fair for this year. We still have a number of events planned for the remainder of the year but they will continue to be contingent on the what COVID-19 rules and regulations remain in place as we come

up to our planned event dates. We remain hopeful that next year will be different and we look forward to putting together a great EV Street Fair 2022.

For most local businesses the COVID-19 pandemic has been a difficult time for them. With this in mind we are very pleased to see almost all of the businesses in East Village remain in business. We also welcome the opening of three new businesses since October 2020; Olympia Liquor, Subway, and Canna Cabana. We look forward to being able to continue supporting our local East Village businesses.

As we all adapt to the a new "normal", we will continue to participate in the building of an inclusive, thriving, and vibrant community where all are welcome to live, learn, work, and play.

On behalf of all of us on the board, we want to thank you for your active interest and participation in the East Village Neighbourhood.

EAST VILLAGE & THE EAST VILLAGE NEIGHBOURHOOD ASSOCIATION

Spanning 49 acres between Fort Calgary and the downtown business core, East Village resides at the heart of downtown Calgary. The boundaries are the geographical area comprising the municipality described and known as Downtown East Village generally bound on the north by Confluence Way; on the east by 6th Street SE; on the south by 9th Avenue SE; and on the west by 3rd Street SE.



The land where East Village now stands was once traditional territory for the

Blackfoot Nation, prior to the arrival of American fur traders around 1840. In 1875, the Northwest Mounted Police established Fort Brisebois, which later became Fort Calgary. By the time the city of Calgary began to boom in 1906, East Village was a vibrant community with a mix of residential, commercial, service, institutional and industrial activity.

In 2011 the East Village Neighbourhood Association (EVNA) was formed to make downtown East Village a healthy, safe, vibrant place in the heart of Calgary. As a neighbourhood association, EVNA champions the development of the East Village as a thriving neighbourhood community. We work in partnership with a wide range of public and voluntary sector agencies to improve services and facilities for local people.

2021 sees an East Village that represents a truly diverse community. Our borders include marvels such as the new Central Library, The National Music Centre, Fort Calgary, and many unique high-rise towers that were welcomed by the Calgary Drop-In Centre, Salvation Army's Centre of Hope, and Trinity Place Foundation of Alberta's three seniors buildings. We are a community of the young and old, professionals, families, dog lovers, and beyond.

OUR NEW LOGO!



If you can believe it, East Village Neighbourhood Association (EVNA) is now 10 years old! We have seen a lot of changes to our neighbourhood in that time and added many new faces. To celebrate this milestone and to reflect the growth of our community, we are delighted to debut our brand-new logo with you, our family of #EVneighbours! We believe this new design reflects our community's growth and embodies our core values perfectly!

The new logo features a colourful cityscape, with five buildings of various shapes and sizes, plus our iconic George C. King "Skipping Stone" Bridge in front. This imagery helps differentiate our neighbourhood from others in the city, as we are uniquely high-rise oriented. The six vibrant colours help convey our fun and lively nature, while also paying homage to the diversity of East Village's residents and guests.

Below the cityscape lies our nameplate in a seventh colour, steel-blue. Two versions of the typographic elements are used: our full name is for regular use, while the shortened "YYCEVNA" name is reserved for social media platforms. Anchored beneath the nameplate is a graphical representation of the brick pavers that permeate our neighbourhood and make our streets so unique. By using this brick pattern, and incorporating orange within its new rainbow of colours, the new logo gives a loving nod toward its predecessor. Likewise, the words "East Village" continue to be the dominating text, as the neighbourhood remains the central focus of the association.

The new logo is finished by being wrapped in a double-lined circle of steel-blue to illustrate the unity and resiliency we've shown through the years. Whether it be the losses felt by decades of urban renewal schemes, the devastating floods of 2005 and 2013, or the socially-isolated pandemic of 2020, we think you'll all agree that this neighbourhood has seen and been through a lot of hardships. But getting us through it all is a strong and compassionate group of diverse individuals who care and help their neighbours in times of need. This is the true heart of the community that we aimed to capture within our new logo.

Our Revitalization Committee was established last year in response to the opportunity afforded us by COVID-19's pause on 'normal' life. The committee was given the time and resources needed to look inward and renew EVNA's outlook for the coming years. This included overhauling our website and communication tools, as well as updating our vision and mission statements. Our vision at EVNA is to support an inclusive, thriving, and vibrant East Village where all are welcome to live, learn, work, and play. Our mission is to encourage conversation and interaction to create a sense of belonging and ownership for all who live work and play in East Village. NEW BYLAWS FOR EVNA

The Board has created and posted to the EVNA website a new set of bylaws for your approval. The main purpose of these updated bylaws is to modernize and simplify the current bylaws from 26 pages down to 9 pages.

The team working on the bylaws and the connected Policy and Procedures Booklet have scrutinized the Societies Act, including the recent March 26, 2021 updated version, to ensure all requirements are met fully. Additionally, we reviewed and compared bylaws between numerous community associations throughout Calgary. The Board is confident we have created functional encompassing bylaws that will help guide the direction of the EVNA for years to come.

COMMITTEES

Our committees are the driving force behind the East Village Neighbourhood Association. This support from our community members brings in different backgrounds, values, viewpoints and wide-ranging abilities. Pooling of our shared knowledge and experience allows us to achieve more, motivates forward momentum and improve the quality of decisions we make in our continued effort to improve services and facilities for our EVNA neighbours.

Finance Committee

The Finance Committee is a standing committee whose goal is to ensure that the board of directors fulfils its fiduciary responsibility relating to: financial auditing and reporting, financial policies, and financial risk management to ensure the effective operation of the organization. They review monthly financials statements, support creation of the annual budget prior to its introduction to the Boards, and they research, review, develop and propose organizational policies and procedures relating to fiscal management.

Planning Committee

The EVNA Planning Committee reviews all applications for land use re-designations (rezoning), subdivision, and development permits to provide feedback to the applicants as to how their application fits — or could better fit — within the community's values and vision for its growth. Additionally, the committee is to take proactive opportunities to affect change in East Village by addressing issues such as traffic, parks, heritage conservation, and community improvements.

Events Committee

The Events Committee is a standing committee whose goal is to plan and operate an annual series of events to be held in East Village to provide residents of East Village opportunities to meet and socialize. The role of the committee is to ensure that the organization has in place effective management policies, procedures and systems to ensure the effective and fiscally responsible operation of the events. The committee generates concepts and ideas for events, plans and execute those events including the securing of all permits and permissions required and work with all partners and community members involved.

Garden Committee

The Garden Committee is a standing committee whose goal is to oversee the general administrative functions and operation of the Crossroads Community Garden and whose membership is drawn from those who have a plot in the garden. The committee is responsible for the operation and maintenance of the garden, reviewing applications of interested gardeners, allocates plots and collect all fees. This team created the safe and tidy community garden we see today; a gratifying environment in which to work, and a pleasant view for gardeners, neighbours, and the general public.

Marketing Committee

The Marketing Committee is an advisory committee that works to expand EVNA's presence, enhance its image & credibility throughout Calgary by acting as a sounding board for marketing strategies and tools, develop and hone innovative ideas, and helps develop events, campaigns, and community initiatives. They also support any grant or funding applications and provide feedback on communications plans, materials, and are the drivers of our social media presence.

2020 FINANCIAL COMMITTEE REPORT & FINANCIAL STATEMENT

EVNA finds itself in a good financial position as a not-for-profit society. With continued prudence we will be setup to support the community for many years to come.

We saw a healthy increase in our portfolio with a Rate of Return of around 9% for the twelve months of 2020.

The board has continued to review in detail our finances, confirmed all filings are completed and up to date, reviewed policies and procedures, and have updated our accounting software. Additionally we have contracted a firm, Evergreen Business Solutions, to maintain our records ensuring continued accuracies and efficiencies so that we can focus on our financial health.

Our proposed budget discussed in the early part of 2020 was based on 2019 plus inflation, and therefore became inapplicable due to the exceptional circumstances of the pandemic. In the detailed, five year history Statement of Revenue and Expenditures below, we show that there were very low expenses in 2020 while at the same time unfortunately, losing revenue due to the required cancellation of the 2020 Street Fair. There was a slight increase in our G&A expenses for website rebuild and maintenance, and brand redesign. This was again, offset by the low event expenses.

2020 Audit

EVNA has engaged Shahid Naqi Professional Corporation to complete an audit of our books for 2020, as well as a detailed review of the intervening years between the current audit and the past audits. They are a local, Calgary firm whose main focus is providing audit services to not-for-profit organizations. We expect to have the result by September 2021 and will share those results with the community.

Additionally, although we will do not require another audit for 2021, EVNA intends to engage Shahid Naqi Professional Corporation again to review our 2021 finances. This will ensure that we continue to follow best practices and our records are impeccable for any new Board members that we expect to join the Association in 2022 as the neighbourhood continues to grow.

PLANNING COMMITTEE REPORT

The East Village continues to evolve, even during a global pandemic. In 2020, our EV park space was a popular way to get outdoors and keep safe social distance. The Riverwalk, St. Patrick's Island and Fort Calgary saw more people, dogs, bikes, and skis than it has in years. COVID-19 brought some innovative ways of engaging with our public park space including the CMLC initiatives like picnic tables and fire pits along the river walk, the East Village Nordic Loop, pop up installations on St. Patrick's Island, and outdoor fitness classes.

The EV was part of the winter Chinook Blast Festival (Feb. 2021) and welcomed art installations at Celebration Square and along the Riverwalk near the Simmons Building.

In the spring of 2020, The Real Canadian Superstore opened as the flagship tenant in 5th&Third becoming a much needed urban grocery amenity. The shopping complex continued to fill in and by mid 2021 it houses TD Financial, Scotiabank, Fresh Slice, Olympia Liquor Store, and Subway.

Construction on the Arris tower (above 5th&Third) was completed and construction fencing and cranes were removed from 4th St. SE and 6th Ave. SE. and opened for rentals in early 2021.

After 8 years, the East Village Experience Center on Riverfront AVE SE has been converted to office space for Harvest Builders, in addition to the space the company occupies in M2.

Recently, the 9th Avenue Parkade and Platform Innovation Center (9th Avenue SE and 3rd St. SE) completed construction and we look forward to discovering the opportunities this unique building has to offer!

At long last, Carya moved into the newly renovated Village Commons (8th Ave. SE & 5th St. SE) in East Village Place (in partnership with Calgary Housing Company and CMLC) in early 2021. We are so fortunate to have a community hub and look forward to future events when it it is safe to gather again.

In total, EVNA received and responded to five (5) Development Permits in 2020 and six (6) so far in 2021. The majority of these have been change of use and upgrades to exterior due to COVID-19 restrictions.

EVENTS COMMITTEE REPORT

Due to restrictions on social gathering imposed by the COVID-19 pandemic, many of the annual summer events hosted by EVNA were put on hold. However, during the Christmas season, the Events Committee looked to engaging residents through its social media channels such as Twitter and Instagram as well as EVNA's brand new website.

Derek Visits East Village

During the month of December leading up to Christmas day, Derek the elf visited various sites in the neighbourhood.

This initiative was to promote fun amenities and spaces in the neighbourhood, and to also bring Christmas spirit to the community. Content of the posts included Derek exploring in the neighbourhood, sharing holiday recipes, and favourite Christmas movies. There were daily posts for 25 days which boosted EVNA's online presence with 500 different accounts reached, 402 interactions and 3.3% increase in Instagram followers. The website also received 321 additional visitors.

Light Up the Village

In addition to Derek's adventures, the Light Up the Village initiative was also promoted within the social media channels. This event was to encourage residents to have Christmas lights on their balcony leading up to the Christmas holidays. Though we could not celebrate the holidays with our loved ones, this was a great way to bring Christmas cheer in the community. On Christmas Eve, the final count came in at 309 balconies reaching the intended goal of 300.

EVNA continues to monitor and adjust to the changing restrictions and we hope to host community events as soon as the restrictions allow us to do. We look forward to seeing everyone again at EVNA's events in the near future.



GARDEN COMMITTEE REPORT

To begin, EVNA would like to acknowledge and thank Susan Hooper. Susan officially stepped down as our garden coordinator effective May 8, 2021. Susan, on behalf of everyone on the board, and the entire East Village Neighbourhood, you have our great appreciation for the work and dedication not only to the garden but all of East Village. We have the most beautiful garden in the City and in no small part because of her commitment.

In 2016, Calgary Municipal Land Commission (CMLC) provided a garden area for 88 garden plots. These include raised beds for those with mobility challenges, accessible water and a communal garden shed.

The garden opening in April 2020 adapted COVID-19 protocols and currently in 2021 we continue to implement these safety measures; the garden shed remains closed, all participants use their own garden tools, watering cans and maintain social distancing, as well as wiping any surfaces and wearing masks as appropriate.


Also as part of our 2020 garden opening, individual bags of soil were placed on each garden plot. After another successful season, the garden closed for the winter season on Friday October 16th, 2020. In the spring of 2021, CMLC and the Landscaping crew replaced the water taps for easier access for the new season to come.

Registration opened for returning gardeners on November 17th, 2020. The new registration system requires that a membership which will now renew on an annual basis be purchased for \$7.00 prior to renewing a garden membership which is now \$33.00 effective November 2020. All in, the price for garden is \$40.00. For those without online access, cash payments were accepted.

Registration opened for new gardeners on March 01, 2021 and we continue to have a waiting list for hopeful gardeners. The garden officially opened for 2021 on May 8th on a very cold and rainy day where social distancing was easily maintained. All participants received a garden welcome kit containing a handbook, a package with sterile gloves and mask as well as miscellaneous garden items. The deadline for planting is June 15th, 2021 and we look forward to seeing our gardens grow.

In the coming months, we will host events and surprises on Wednesdays. Again, thank you to Susan for her planning and imagination. Rather than give away any surprises, the results will be part of the next garden report.

A big thank you to our partners: Green Meadow Landscapes and Calgary Municipal Land Corporation for your continued assistance with soil, irrigation, funding and events. This year for your assistance in the maintenance and cleaning of the garden shed. Thank you to First on Colour for the printing of garden handbooks and the gift of the Salsa Cookbooks for all gardeners! Finally, thank you to Stan Furber for staying on as gardener and our handyman. Stan is the invisible garden fairy who makes garden hoses and locks appear as if by magic. Thank you, Stan.

"Bee" Compassionate!

The past year has taught us about empathy and compassion for others. It has also changed our way of thinking around sustainable cities and communities, and what they should look like. Empathy opens our eyes and hearts to how other people see and experience the world, and this extends to our natural world. As bee and pollinator populations continue to decline, the environment, and the living creatures that sustain us need our empathy.

Empathy for our natural environment is pivotal to address declining native bee and pollinator populations. While this global issue might not appear to impact us directly, pollinators drive our food systems and are essential to meet our most basic needs. Calgary Parks transformed our parks and transportation networks into naturalized, pollinator friendly habitats, and we have been rewarded with sightings of endangered native bees! We need to maintain our "Bee City" designation and building environmental empathy is an important piece.

Through the "Bee a Polli-Neighbour" program, launched in 2020, Calgary Parks developed "nature learning kits" for schoolteachers and students to grow their understanding of how human health and the natural world is linked, and how our actions impact the environment. By offering tools to expand ecological knowledge, appreciation, and a sense of wonder at an early age, we are working towards building environmental empathy.

From halting the use of pesticides, to making lawns smaller and flower beds bigger, from planting more native species to leaving the leaves over the winter there are many ways we can promote and preserve bee habitats in our own yards. The more we develop environmental empathy in ourselves and our young people, the more likely we will be successful.



Downtown East Village Crime Activity was Down in April 2021

The Downtown East Village community experienced 21 crimes in April 2021, in comparison to 22 crimes the previous month, and 44 crimes in April one year ago. Downtown East Village experiences an average of 20.5 crimes per month. On an annual basis, Downtown East Village experienced a total of 246 crimes as of April 2021, which is down 33% in comparison to 369 crimes as of April 2020. Total Downtown East Village crimes is calculated as the sum of break & enters (dwelling, commercial, and other premises), theft from vehicles, theft of vehicles, assaults (nondomestic), commercial robberies, street robberies, and non-domestic 'other' violence.



The Downtown East Village community experienced 2 break and enter (B&E) crimes in April, in comparison to 3 B&E crimes in March and 4 B&E crimes in April 2020. On an annual basis, Downtown East Village experienced a total of 28 B&E crimes as of April 2021, which is down from 65 B&E crimes as of April 2020.





Downtown East Village experienced 4 vehicle related crimes (theft of or theft from vehicles) in April 2021, in comparison to 2 vehicle related crimes in the previous month, and 23 vehicle related crimes in April 2020. On an annual basis,

Downtown East Village experienced a total of 49 vehicle related crimes as of April 2021, which is down in comparison to 120 vehicle related crimes as of April 2020.

Physical and social disorders are excluded from this article because a very low proportion of disorder-based calls for service result in crime reports. Physical and social disorders are often highly visible, occurring in public spaces; examples include drunks, panhandling, youth gangs, prostitution, littering, loitering and graffiti. Research indicates that disorders can have a negative impact on public perceptions of safety. See the Downtown East Village Crime Activity Table for additional information.
